Like calcium carbonate ( $CaCO_3$ ), calcium sulfate ( $CaSO_4$ ), barium sulfate ( $BaSO_4$ ), strontium sulfate ( $SrSO_4$ ), silica (Si), calcium fluoride (CaF) and also controls iron, aluminium and colloids. It also helps in the removal of existing scale.
